### Work in Progress

Indifferent Federalism, Equal Protection & Due Process Violations in Child Support Enforcement - Federal law requires welfare-recipient custodial parents to cooperate in establishing child support orders against the non-custodial parent and to assign their right to receive support to the State. That assignment, in the eyes of agency administrators, renders an otherwise essential witness, the custodial parent, irrelevant to the process of obtaining an order. This legal fiction results in settlement practices which deprive the non-custodial parent of a meaningful opportunity to be heard and to confront an adverse witness in violation of the Fourteenth Amendment. In turn, the disparate treatment of these parents violates the well settled guarantee of the Equal Protection Clause, that similar treatment will be afforded similarly situated persons.
