EMPLOYMENT HISTORY

Professor of Law, Seattle University School of Law (1982-87, 1990 – present) (tenure grant 2000)

Teaches Evidence, Evidence Lab, Forensics (expert witnesses), and Criminal Procedure.

Created Evidence and Criminal Procedure "Lab Courses," and accompanying workbooks for Seattle University School of Law. Workbooks chosen by American Association of Law Schools to be displayed at 1984 national conference as innovative contributions to legal education and are now part of skills development series published by the Michie Company.
