Seattle University, School of Law, Seattle, Washington, July 1990 to present

I am currently a Professor of Law (with tenure) at the School of Law. I teach "Torts," "Constitutional Law," "Health Law," and "Public Health Law" courses.

University of Washington, School of Public Health and Community Medicine, Seattle, Washington, July 1990 to August 2003

I was a Professor of Public Health Law (part-time) in the Department of Health Services. I taught "Health Law" and related courses.

The University of North Carolina, Chapel Hill, North Carolina, July 1977-June 1990

I was Professor of Law (with a joint appointment) in the Department of Health Policy and Administration in the School of Public Health and in the School of Law.

My law school teaching included "Health, Policy, and Law" (an introductory course for law students), "Advanced Seminar on Health Law" (a research seminar for law students), Products Liability, and Torts (first year).

My public health school teaching responsibilities included "Health Law" (an introductory course for public health and medical students), and "Hospital Law" (a seminar for public health and law students).

I was the Deputy Civil Rights Officer for the Department of Health. My primary responsibility was the enforcement of Title VI of the Civil Rights Act of 1964 and other anti-discrimination laws relating to equality in health service delivery, both in departmental programs and in services delivered by contractors and licensees. I also acted as legal adviser to the Director of the Department on special projects; these projects included the implementation of health planning programs, the recognition and enforcement of patients' rights, the development of state policy on the maintenance of public hospitals, and the enforcement of the free service and community service obligations of Hill-Burton hospitals.

During the 1974-75 academic year, I taught under a joint appointment as an Assistant Professor of Health Education and as a Lecturer at the School of Law at the University of Oregon.

As a staff attorney, I was responsible for law reform litigation in a variety of areas including access to health care, health planning activities, mental health, and patients' rights.
