#### News

**TILE Institute Website:** 

Over the summer, TILE Research Assistants Tanveer Kaur (LL.M. '25) and Brandon McNeel (Flex JD '25) applied their webmaster skills to update the <u>TILE Institute website</u>. #### **TILE Certificate:**

Graduating JD students are eligible to apply for a TILE certificate. Awarded to students who meet rigorous requirements, this certificate is noted on the students' diplomas and transcripts. The certificate currently requires 20 minimum credits of TILE-related coursework.

If you are a JD student who is graduating in December 2025, please submit <u>your application</u> by **September 15** to TILE Faculty Director and Professor <u>Maggie Chon</u>. If you are a JD student graduating in May 2026, please plan to submit your application by **January 12, 2026** to Professor Chon. Non-graduating JD students can use the application form as a guide to choosing courses.

#### **Welcome to New TILE-Affiliated Faculty:**

Please welcome three new career faculty members affiliated with the TILE Institute and who are prolific scholars in a variety of technology law subject areas. Assistant Professor Chryssa Deliganis (whom some students might have already enjoyed as a visiting professor) has joined the career faculty and will continue to teach courses related to health law, in addition to civil procedure, professional responsibility, and property. Joining the career faculty from Gonzaga Law School is Associate Professor Jeffrey Omari, who teaches media law, in addition to administrative law and constitutional law. And Assistant Professor Mark Verstraete teaches privacy law as well as other technology law courses, in addition to property law. We are fortunate to have such a talented group of new professors join our already impressive roster of TILE-affiliated faculty, both adjunct and career.

#### **Deadline for Seattle IP American Inn of Court Applications:**

The <u>Seattle Intellectual Property (IP) American Inn of Court</u> is an organization dedicated to improving the skills, ethics, and professionalism of the Seattle IP Bar, with participating law students, lawyers, academics, and judges. Members typically meet once per month during the academic year on Thursday evenings for networking and a continuing legal education (CLE) program focused on education and skills development.

Students who join the IP Inn of Court are required to attend monthly meetings and participate in presenting CLE programs. The law school underwrites students' membership fees. 2Ls and 3Ls may apply for membership by sending an updated one page resume and a thoughtful and compelling statement of interest (maximum 250 words) to <a href="Matter">Matter</a>, Assistant Dean of the Center for Professional Development. Your statement should describe your interest in IP and why you wish to join the Seattle IP Inn of Court. Applications are due on **Friday, September 5 at noon**.
