**REMINDER—Spring 2025 Courses (Including 7 New Courses!):** Next semester, TILE will offer courses that address multiple aspects of law and technology. A couple of the interdisciplinary courses are highlighted in more detail here because of the limited enrollment. The full list is below:

• <u>Investing in AI companies: Tech, Business, and Legal Perspectives</u> (INTP-396) 2 credits

How do venture capitalist firms choose which start-ups they will invest in? In interdisciplinary teams of engineering, business and law students you will conduct tech, financial, and legal diligence on an actual AI start-up in Seattle and prepare an investment memorandum for a Seattle-based venture capitalist firm. Taught by tech, legal and business industry experts and academics, this course will also include guest lectures from founders of the AI start-ups and venture capitalists. You will learn how to evaluate AI start-ups intellectual property and legal risk, marketing plans, future growth, viability of the technology in the competitive landscape, long-term exit strategy, and financial diligence. No prerequisites. *Limited to 12 students* (4 from business school, 4 from law school and 4 from science & engineering); cross Listed with Albers School of Business & Economics and College of Science and Engineering courses and meets on the quarter schedule.

## • Ethical Legal Tech Innovation (LPRC-440) 2 credits

This course offers Law students a unique opportunity to collaborate with graduate Computer Science students to design and prototype legal technology

tools aimed at addressing challenges in legal workflows and access to justice. The interdisciplinary teams of students will work together to develop and present a legal technology project. Throughout the process, students will examine key ethical and design considerations. The course will include both synchronous class sessions and flexible, self-scheduled group work outside of the classroom. No pre-requisites. *Limited to 4 Law students* (to participate in 2 teams with 2-3 Computer Science students on each team). A technical background is not required. **E-Discovery Workshops Coming Soon**: The Law Library is pleased to offer a series of e-discovery workshops beginning in January. Students will have the opportunity to learn the fundamentals of e-discovery, and to interact with DISCO, an e-discovery platform. **Quotes from our TILE Professors**: Over the summer, TILE Research Assistant and 3L <u>Ania Smeraldo</u> interviewed some of our adjuncts and visiting professors, to get their perspectives on what their courses offer students. Here are some quotes from <u>Visiting Professor Chryssa Deliganis</u>, who is teaching a seminar on <u>Food and Drug</u> <u>Regulation</u> this semester:

- There are so many issues *right now* to discuss. One of them is the FDA's denial of MDMA, a psychedelic that has been closely studied just recently for its potential to help people with chronic PTSD. The study appeared to be very positive, but the FDA decided to not OK any use of MDMA for that purpose. There are a lot of people suffering, especially military population, suffering from PTSD. These topics are fascinating and consequential. [And] there are so many interesting psychological issues going on, for example from the pandemic with vaccine hesitation, and biologics is on our syllabus. The FDA's expeditious approval of these vaccines saved many lives.
- Shilpa Prem from Amazon's startup sector called Amazon Lab 126 will be a guest speaker to discuss emerging new technologies and how you navigate the regulatory gauntlet.
