On **Tuesday, October 8**: If you are a student with a degree (or at least two years of coursework) in engineering, computer sciences or the hard sciences (chemistry, biology, physics, or related fields), and are interested in becoming a Patent Agent or Attorney, <u>Practising Law Institute (PLI)</u> invites you to a presentation by <u>Mark Dighton, PLI's Director of Law School Relations</u> and Administrative Director of their Patent Office Exam Course. Mark will discuss: the latest info on the Patent Office Exam, who can take it, how it works (it's on computer and "on demand"), when you should take it (you don't need to and probably shouldn't wait until you graduate), and recommendations on when and how to study for this very difficult exam. New TILE Certificate Program Reminder: As announced in the summer TILE newsletter, the TILE Program now offers a new TILE Certificate for graduating J.D. students. If you are in your final year of law school, please consult the information <u>provided here</u> for important information on how and when to apply.

International Association of Privacy Professionals (IAPP) Discount Available: Students interested in getting an <u>IAPP certificate</u> qualify for a discounted fee for any of the IAPP exams. Enrolled students pay only \$100 for each exam. Ever since the TILE Program announced our collaboration with IAPP last September, about two dozen Seattle U Law students have signed up for this program. And we are pleased to congratulate LL.M. student <u>Esther Arokun (earokun@seattleu.edu</u>) for passing the CIPP exam this summer! From 2L Darian Mullen: Law School Link is a program that is available through the American Intellectual Property Law Association (AIPLA) and that provides its student members with access to <u>mentoring</u>, networking, and <u>education</u> opportunities across the country in both in-person and online formats. <u>Membership</u> in Law School Link is only available to student members of the AIPLA, and is free for the first time this year to students currently enrolled in law school.

Students may be assigned directly to a mentor in a 1-on-1 or in small group format. These mentors will guide students throughout their law school careers and beyond. The AIPLA maintains a strong relationship with recent graduates, supporting them through the <u>new lawyers</u> division until they are ten years out of law school. Additionally, the AIPLA focuses strongly on networking, by hosting several events throughout the country. Student rates are available for those who decide to travel to conferences. Finally, the AIPLA supports students with <u>scholarships</u> and awards through application or placement in moot court competitions.

Washington State-TILE Patent Pro Bono Hub: The TILE Program is pleased to announce the launch of the <u>Washington State-TILE Patent Pro Bono Hub</u>, in collaboration with the <u>U.S. Patent and Trademark Office</u>. This Hub connects qualified low-income inventors in Washington state with experienced patent

Quotes from our Adjunct Professors: TILE is extremely fortunate to have a terrific group of knowledgeable, experienced, and generous practitioners who also serve as <u>adjunct professors</u> associated with the Program. Over the summer, TILE Research Assistant and 3L <u>Ania Smeraldo</u> interviewed some of our adjuncts and visiting professors, to get their perspectives on what their courses offer students. Here are a couple of quotes from Professors <u>Katherine McDaniel</u> and <u>Chuck Cosson</u> on their <u>Cybersecurity</u> course (to be offered again in Spring 2025):

- There will be a scenario in which every head in the room will turn and look at you and ask [if they must comply with certain privacy laws. We're] getting [students] prepared so they not only know the law but have a sense of how to manage one's own emotions in that moment, remember the facts, and think about the arguments for business people besides saying "it's the law." This class is meant to be useful not just as an academic exercise, but a passing of the torch, in a sense. (Chuck)
- The most important skill a lawyer can have is the ability to understand the big picture, and what the client's ultimate goals are, and translate the legal risk into practical advice. This is true in all areas of the law, but it takes a lot more practice in the cyber area because legal risks and cyber risks are one and the same, and some technical concepts can be more challenging to boil down for a business audience. There's a lot of value add for individuals who can both understand the legal side and technical side, and translate all of that into business language. (Katherine)
